# UK

To support employees and their families during the global inflation crisis, Guala Closures UK & UCP collaborate with GroceryAid, an association that aids food industry workers.

GroceryAid Days are organized at local plants to raise awareness of available services.

Guala Closures received a "Bronze" award for these promotional activities.

For the third year in a row, our plants in Bridge of Allan and Kirkintilloch (Scotland) have attained a Gold Award internationally recognized health and safety accolade from the Royal Society for the Prevention of Accidents (RoSPA).

### India

In Goa, Guala Closures funded the renovation of St. John of the Cross School and continues to support the restoration of the pipe organ in the Basilica of Bom Jesus, a UNESCO World Heritage Site, expected to be completed by the end of 2024.

On World Environment Day, the group organized tree planting activities with employees at their Indian plants.

In India, the Group also collaborates with the NGO Vikalp on a reforestation project in Gujarat, providing forest conservation education to over 15,000 students and planting nearly 40,000 trees in 2023.



**ISO 9001** 

This certification refers to Quality Management Systems. It is issued to companies that demonstrate an effective quality management system and meet certain regulatory requirements.
